d. **Trustee Report** – Murray Hollman

Went over RDCRS Board Meeting Highlights (will be posted on the Parent council board). Touched on Accountability Report. Cultural Services building has been handed back over to RDCRS and will house financial services once current renovations are complete, St. Pat's is ahead of schedule and under budget. The provincial budget is on his radar, at time of meeting it had not been released yet.
